#### **About this unit**

**Diversity:** the concept that people are valued as individuals and that different ability; perspectives and approaches are a positive benefit to organisations and communities

#### **Performance criteria**

- 4. Accurately identify significant demographic trends within the target population and **analyse** the implications for demands on services
- 5. Gather full and accurate information about the **outcomes** required by the target population currently and in the future
- 6. Use methods of gathering and handling information that comply with legal and organisational requirements and the need for confidentiality
- 7. Identify existing service provision, the extent to which it meets the required outcomes currently and is likely to in the future and identify any gaps
- 8. Make an objective and thorough analysis of the information you have collected
- 9. Make an objective and detailed assessment of the services and resources required to meet the required outcomes

# CPC 408 B Make recommendations for services based on a needs assessment

#### Performance criteria

You must show that you:

- 1. Consult openly with individuals, families, communities and partners on the results of your assessment and incorporate their views appropriately in your recommendations
- 2. Base your recommendations on a full and comprehensive assessment of the needs of the local population for services
- 3. Clearly identify any gaps in the information you have gathered and any assumptions you have made
- 4. Specify clearly the range, volume and method of accessing services required in your recommendations

- 5. Take account of local and national policies and priorities in your recommendations, particularly the increase in self- directed support
- 6. Take careful account of the **diversity** of the local population and the rights of individuals to equal access to services in your recommendations
- 7. Ensure that your recommendations are consistent with recognised good practice in commissioning
- 8. Present your recommendations clearly, concisely and in an accessible format with sufficient information for decision makers to agree priorities and the strategies required to meet them
- 9. Provide further information and interpretation to help decision makers understand the implications of your recommendations, where required
- 10. Ensure that your recommendations take account of the financial framework and resource allocation within which you work
